1.0 Opening Remarks

7.0 Reports

7.1 Kathy Spate, Region 10 Director

Ms. State reported the annual CSBA conference starts in 98 days. It will be held in San Diego. She noted the legislative session will end August 31. CSBA lobbied hard for transportation funds. This is the first time since the 1980's that new funds for home to school transportation services have been included in the budget. This is an election year. She stated 29 seats are open in Madera County. Only six of those are contested elections.

8.0 Introduction of Program

Assessing Student Threats School Safety: A Shared Responsibility Plus Tips on Social Emotional Learning Presented by Dr. Rod Keeler

Dr. Massetti introduced Dr. Keeler, who worked as at teacher at Millview Pre-school, Madera High School, and Oak Creek Intermediate for approximately seven years before he began working as a Behavior Intervention Specialist at Madera County Superintendent of Schools. Dr. Keeler earned a bachelor's degree from Occidental College, a master's degree from National University, and a doctorate from Walden University. Prior to working in education, Dr. Keeler was employed for nine years as a real estate broker in Southern California. Dr. Massetti joked that Dr. Keeler can sale anything.

Dr. Keeler asked attendees to think about what may be the single greatest inhibitor for a student who is preparing to engage in an aggressive act in school before beginning his presentation.

Dr. Keeler provided haunting facts about Bath Township School Board Treasurer Andrew Phillip Kehoe who served from 1924 to 1927. In 1927, Kehoe murdered his wife and then detonated bombs at the Bath Consolidated School killing 38 elementary school children and six adults. He also injured 58 other individuals before detonating a

bomb in his own vehicle killing himself and the superintendent he was speaking to at the time. The Bath School massacre remains the deadliest school attack in American history. Dr. Keeler provided statistical information about threats in schools and explained mass shootings tripled between 2011-2015. Dr. Keeler revealed that the single greatest inhibitor for a student who is preparing to engage in an aggressive act in school is having at least one positive relationship with a school staff member on the campus. Dr. Keeler believes a system to evaluate threat is imperative. Dr. Keeler will be providing workshops on the Salem-Keizer Cascade System: a multi-disciplinary, multi-agency collaboration designed for use in the educational setting. He noted this system assesses situations, not people. Trainings will be held September 9 and October 14 at the MCSOS Conference Center from 8:30 a.m. – 3:00 p.m. The cost to attend is \$25 with breakfast and lunch included. The recommended audience includes administrators, psychologists, counselors, school resource officers, teachers, and board members.
